#### **Research Activities**

His **research activities** focus on the management of innovation, and in particular the management of R&D activities in both industrial firms and public and private research institutions. His main interests regard the organisation and evaluation of R&D activities and the collaboration between

firms and research institutions in the innovation process. In particular, he is doing research about academic spin-off companies, national innovation system in Europe and Latin America, industrial dynamics in the microsystem technology sector. He has written several paper and book chapters on university-industry relationships, science and technology parks, R&D organization, high-tech spin-off companies. He has organised the 1995 R&D Management Conference on "Knowledge, Technology and Innovative Organisations" held in S.Miniato, Italy, in September 1995.
